Know Yourself

 Your interests, personality strengths, values (political, social, religious), need for autonomy / support, lifestyle needs

What are your interests? Review your resume

- What volunteer work are you attracted to? What academic subjects excite you?
- What issues / topics do you like to read / talk about? Take a personality test; use a book or other resources that discuss career options for your personality type (e.g., Meyers-Briggs; Do What You Are; Career Match)

What are your Personality Strengths?

- Do you want to have more client contact? Yes→ in-house counsel, small firm, administrative law, bankruptcy, employment, immigration, entertainment, family law
- Do you want to have more colleague contact? Yes→ larger firm, government, environmental, energy, healthcare, insurance, IP, municipal, real estate, appellate litigation
- Do you enjoy public speaking? Debate? → litigation, general counsel
- Do you like to work alone? Yes → appellate practice, judicial clerkship, judiciary
- Do you prefer working with ideas more than working with people? Yes → appellate practice, judicial clerkship, environmental, healthcare, insurance, intellectual property
- Do you like to read and construe codes / regulations? Yes → administrative law, bankruptcy, corporate, employment, environmental, energy, healthcare, municipal, tax, appellate litigation

What are your values?

- Is it important to feel like you are helping society with your job? / Do you want to advocate for causes you believe in?
- Do you enjoy an intellectual challenge?
- Do you want to work for a well-known firm and/or earn a larger/income?

What are your needs for Autonomy / Support?

- Do you want a lot of responsibility and autonomy early in your career? Yes → small firm, solo
 practice, district attorney, public defender, JAG
- Do you want a more formal setting? Yes → large firm, government
- Do you want a more casual setting? Yes → small firm, public defender, solo practice
- Do you want access to more resources? Yes → large firm, mid-sized firm, government
- Do you want more personal interaction? Yes → ask the employer during the interview to see how much client and colleague interaction you would have
- Do you want to work independently? Yes → solo practice

What are your lifestyle needs?

- How much time do you want for friends, family, hobbies, etc.?
- How much control do you want over when you work and when you have time for other pursuits? How much money do you need to live comfortably?
- Geographically, where do you want to live? Do you want to work for an employer whose name people recognize?

Once you hone in on a few areas of interest...

- Attend attorney-panel events on campus, bar association practice area events, and arrange informational interviews with attorneys and alumni.
- Explore practice areas that seem appealing during school or over the summer
- Join student groups in intriguing practice areas.
- Compete in writing competitions.
