### **Bakhtiyar Aslanbayli**

Mr. Bakhtiyar Aslanbayli is a Lecturer of the Baku State University. His main areas of expertise are the security, energy politics and fiscal aspects of the energy projects. He has spoken at numerous institutions, universities, think-tanks and is frequent speaker at international conferences.

In 2001 he was winner of the Scientific Competition on Oil and Gas Researches conducted by the Ministry of Education and National Academy of Sciences of Azerbaijan. In 2009 he was honored with special Emanuel Nobel Memorial Medal by Baku Nobel Heritage Fund for implementation of World Energy Politics discipline at Baku State University and researches on contemporary energy politics.

Mr. Aslanbayli is the author of one book and more than 50 professional articles and commentaries. He holds BA and MA in International Relations from the Baku State University and is currently PhD researcher at the Azerbaijan National Academy of Sciences.

### **Christian Burgsmüller**

Dr. Christian Burgsmüller is a career EU diplomat with the European External Action Service (EEAS). Since 2010 he has been serving as Counselor at the EU Delegation to the US in Washington DC where he heads the Energy, Transport and Environment section.

Christian is a lawyer by training and joined the European Commission in Brussels in 2000. Over the following 6 years he held posts both in the Commission's Directorate-General for Enterprise and Industry as well as in the Directorate-General for Trade. He finished his Brussels years as coordinator for EU-US trade and investment relations. Continuing his career overseas Christian headed the Political, Economic and Public Affairs section of the EU Delegation to Brazil in Brasilia from 2006 to 2010.

Christian studied law in Freiburg im Breisgau, Geneva and Cologne and holds a Ph.D. in constitutional law from the University of Cologne. He has been a visiting lecturer on EU and German politics at Sciences Po Paris and the University of Sao Paulo.

### **Avinoam Idan**

In addition to his policy research, Dr. Mankoff teaches courses on international security and Central Asia at Georgetown University's School of Foreign Service and at the School of International and Public Affairs at Columbia University.

Dr. Mankoff has held academic fellowships at Harvard, Yale, and Moscow State Universities. He holds dual B.A.s in international studies and Russian from the University of Oklahoma and an M.A., M.Phil., and Ph.D. in diplomatic history from Yale.

Prior to joining the Atlantic Council, Taner served as CEO and vice chairman of a Turkish conglomerate, with companies operating in the technology, finance, social media, and real estate sectors. During his career as an investment banker, he spent fourteen years with Bankers Trust Company in New York City, where he completed pioneering work in the bank's capital markets, treasury, emerging markets, and venture capital divisions, rising to the position of managing director.

While at Bankers Trust, Taner established Turk Merchant Bank, an Istanbul-based joint-venture investment bank in the late 1980s. In the mid-1990s, he developed an interest in the new economy, which led him to start the Bankers Trust Internet Division in 1995, and eventually the bank's first Corporate Venture Capital Group in 1997. Following his successful career on Wall Street, Taner cofounded and later served as chairman of the Turkish American Business Forum, a not-for-profit business association headquartered in New York City.

Taner graduated with honors from Hamilton College in Clinton, New York, where he majored in economics and mathematics. He received his graduate degree in administration, planning, and social policy from Harvard University's Graduate School of Education.
