Role

The Institutional Compliance Committee (ICC) supports Chapman University in providing broad oversight of university-related regulatory issues.

Responsibilities

The ICC:

- 1. Provides guidance and input on the development of a comprehensive compliance program.
- 2. Identifies and discusses compliance-related topics that could affect the university.
- 3. Promotes compliance within the members' respective units and throughout the university.
- 4. Aids in the identification of compliance risks where exposures may not be fully addressed.
- 5. Assists in the identification of compliance-related educational needs.
- 6. Identifies policies and procedures that are needed to ensure regulatory requirements.
- 7. Develops, implements, and improves the compliance program within the members' respective units, based on best practices delineated in the U.S. Federal Sentencing Guidelines.
- 8. Encourages open communication among campus compliance units and senior universityleadership.
