
# The Institutional Compliance Committee

Institutional Compliance comprises of activities that support coordination, management, and monitoring of the risks associated with federal, state and local laws and regulations.






#### **Legal Affairs**

Research Department

#### **Office of Provost**

Enrollment Management works with departments across campus to support prospective and current students and their families.
