# Hands-on Training

Named one of the best law schools for practical training, the Fowler School of Law provides a rigorous legal education rooted in a practice-prepared curriculum. We teach both tangible skills and conceptual theory. We seize the opportunity to represent real clients and strategize with some of the brightest legal minds in the nation. Everything we do prepares our students to become the best lawyers possible, so that when the world calls on them, they will be ready for anything.



#### **Experiential Learning Opportunities**

We're committed to training skillful, ethical lawyers. That's why we've established innovative and exciting clinical, externship and other placement offerings, giving students invaluable hands-on experience and providing real benefits to the surrounding community.

In our legal clinics, students work on actual cases under the supervision of clinical specialists and seasoned practitioners. In addition to classroom training sessions, students engage in hands-on fieldwork with clients, research projects, document preparation, brief writing and court appearances. These clinical programs provide pro-bono services to members of the community in need of legal aid.

#### **Criminal Defense Clinic**

In partnership with the Orange County Public Defender's Office, the Chapman Law Criminal Defense Clinic is aimed at second- and third-year students focused on gaining experience in advocacy, litigation and criminal law. This clinic affords students an opportunity to gain practical experience while working under the supervision of the public defender's office.

#### **Criminal Prosecution Clinic**

Offered in partnership with the Orange County District Attorney's Office, the Criminal Prosecution Clinic provides a unique opportunity for upper-level students interested in exploring careers in advocacy, criminal law and litigation. A senior assistant district attorney teaches the classroom component of the clinic, while students work directly with assistant district attorneys in the courtroom, assisting in the prosecution of felonies and misdemeanors.




#### **Entertainment Contracts Law Clinic**

The Entertainment Contracts Law Clinic provides students with a unique opportunity to work directly with independent filmmakers, serving as production legal counsel for feature length motion pictures. Under the supervision of veteran entertainment law faculty, participating students set up corporations and LLCs, file for copyrights and draft all production-related contracts.

#### Competition Teams: A Winning Tradition

The award-winning lawyering skills competition teams at the Fowler School of Law offer opportunities to practice research, writing, analysis and communication skills. They also provide real-world platforms for students to develop ethics, judgment and professionalism. Students can receive academic credit for approved lawyering skills competitions.

#### **Appellate Moot Court Board**

The Appellate Moot Court program offers students the opportunity to develop oral and written advocacy skills in simulated courtroom settings. Student teams argue challenging legal issues in front of panels of lawyers and judges and prepare written appellate briefs.

#### **Mock Trial Board**

Members of the Mock Trial Board represent the Fowler School of Law at mock trial and arbitration competitions. Teams prepare and argue cases in an actual courtroom, with members of the bench and bar serving as judges. Participants make opening statements and closing arguments, conduct direct and cross-examination of witnesses and raise evidentiary objections when appropriate.

### Alternative Dispute Resolution (ADR) Board

The ADR Board consists of students who participate in client counseling, negotiation and mediation competitions both nationally and internationally.



## Finance Your Future

#### Financial Aid

Attending law school is an investment in yourself and your future. We understand — and that's why we offer a generous scholarship program. We want you to maximize your resources and make the best decisions for your personal situation.

#### Merit-Based Scholarships

Admitted first-year students are automatically considered for merit-based scholarships based on undergraduate cumulative GPA and LSAT at the time of admission. These scholarships are renewable provided students have a cumulative 2.9 GPA at the end of each spring semester.

#### Earning a Merit Scholarship

Students who did not qualify for an entering merit-based scholarship are eligible to earn a scholarship if they rank in the top 15% of their cohort group at the end of their 1L year. Students who qualified for a partial scholarship upon matriculation are eligible for a scholarship increase, if they rank in the top 15% of their cohort group at the end of their 1L year, and the amount earned is greater than their current scholarship.

#### Dean's Kennedy Scholarships

Dean's Kennedy Scholarships are awarded to a very limited group of full-time admitted students with outstanding academic achievements, usually in the top 75% percentile of the student profile, to support their legal studies at Fowler School of Law. These scholarships are renewable provided students have a cumulative 2.2 GPA at the end of each spring semester.

#### Distinguished Student Fellowships

Distinguished Student Fellowships are awarded to a very limited group of full-time admitted students with outstanding academic achievements, usually in the top 75% percentile of the student profile, to support their legal studies at Fowler School of Law. The Distinguished Student Fellowship is disbursed directly to the student in two installments during their first year of study at the Fowler School of Law. Distinguished Student Fellowships are awarded in addition to and separately from Dean's Kennedy Scholarships. These fellowships are renewable provided students have a cumulative 2.2 GPA at the end of each spring semester.

#### First Generation Scholarships

This scholarship is open to admitted students who are the first members of their immediate family to earn an undergraduate degree or pursue a law degree. Applicants with demonstrated commitment and/or history of service to legally underserved communities' populations are given priority. The first generation scholarship application is sent to all eligible first generation students in March. These scholarships are renewable provided students have a cumulative 2.9 GPA at the end of each spring semester.

#### Federal Loans

A completed Free Application for Federal Student Aid (FAFSA) with Chapman University listed (school code 001164) is required to be eligible for Federal Direct Loans and need-based scholarships. Visit studentloans.gov for more information.

#### Private Loans

Private loans are offered by lenders for international students and students who do not qualify or do not wish to borrow federal loans.

#### Yellow Ribbon Program

Through the Yellow Ribbon Program, Chapman University will contribute up to \$17,500 towards qualifying tuition and fees per academic year (and the Veterans Administration will contribute matching funds) for eligible military veterans.

#### **Application Checklist**

To be considered for admission to the JD program, all applicants must submit an application via Isac.org, which includes the following:

- Resume: A description of your work experience, community involvement, volunteer work, scholastic honors and achievements, and/or extracurricular activities after high school. Must be typewritten as an attachment with your electronic application.
- Personal Statement: A brief statement indicating your reasons for wanting to study law, why you chose to apply to Fowler School of Law and any further information you feel should be considered by the Law Admission Committee. It must not be more than three pages in length, must be typewritten in 12-point font, double-spaced and submitted as an attachment with your electronic application.
- LSAT & LSAC's Credential Assembly Service (CAS): Applicants must furnish their results of the Law School Admission Test (LSAT), register for the Law School Admission Council (LSAC) Credential Assembly Service (CAS) and pay all LSAC-mandated fees. Only LSAT scores that fall within the five-year reportable period will be considered.
- Letters of Recommendation: Letters must be submitted through the LSAC Letter of Recommendation Service that serves all member schools. The maximum number of letters we will review is three.
- LSAT, GPA, Adversity Statement: If you believe any item in your application requires clarification, you are welcome to submit a brief addendum to address the issue. However, an addendum is not another opportunity to submit a personal statement; it should be a concise one-page statement addressing a particular aspect of your application.
