Biography

Dr. Schwartzman serves as Chair of the Pharmacy Practice Department at Chapman University School of Pharmacy. She earned both her Doctor of Pharmacy (PharmD) degree and completed a Postgraduate Year 1 (PGY1) Community Pharmacy Residency at the University of Southern California.

She began her academic career at Western University of Health Sciences, College of Pharmacy (WesternU), where she progressed from Assistant Professor to full Professor. While at WesternU, she served as the Director of Residency and Fellowship Training for 10 years, overseeing program accreditations and the Research/Teaching Certificate Program. She was the Director of an ASHP-accredited PGY1 Pharmacy Practice Residency with a focus in ambulatory care for 10 years. Dr. Schwartzman has been precepting residents since 2008 and has also served as a guest accreditor for the American Society of Health-System Pharmacists (ASHP).

In clinical practice, Dr. Schwartzman works in an ambulatory care setting at a Federally Qualified Health Center, collaborating with an interprofessional team to manage chronic conditions, with a primary focus on diabetes care. She holds credentials as a Board-Certified Ambulatory Care Pharmacist, and an Advanced Practice Pharmacist. From 2010-2025 she was a Certified Diabetes Care and Education Specialist.

Dr. Schwartzman's dedication to education and service has been widely recognized. She was honored with the ASHP Foundation's Residency Preceptor of the Year Award, the National Rho Chi Faculty Advisor Award, and the USC Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences Alumni Excellence in Education Award. At WesternU, she received the College of Pharmacy Faculty Service Award twice, as well as the Preceptor of the Year Award. Dr. Schwartzman was named a Fellow of ASHP and CSHP and was recognized by the Irvine Chamber as Executive of the Year in Excellence in HealthCare & Innovation.

She served as President of the National Rho Chi Society from 2020–2022, following her term as President-Elect (2018–2020), and continued her service as Immediate Past President until 2024. Dr. Schwartzman is a mentor through the AACP Pharmacy Practice Section Mentorship Program and is a graduate of the AACP Academic Leadership Fellows Program. She remains actively involved in a number of national and institutional committees.

Her research and teaching interests center on communication skills and preceptor development. She has authored several publications on Objective Structured Clinical Examinations (OSCEs), with a focus on standardized communication assessment, and contributed a book chapter on preceptor development.
